

**ORDINANCE NO. 98-1**  
**ORDINANCE AMENDING THE AMOUNT OF THE TAP FEE**  
**COLLECTED BY JENNINGS NORTHWEST REGIONAL UTILITIES:**

WHEREAS, the Board of Trustees of Jennings Northwest Regional Utilities operates sewer and water facilities known as the Jennings Northwest Regional Utilities ("District");

WHEREAS, the District is required to incur costs for connecting (i.e. "tapping") each customer to the District's sewer and water system; and

WHEREAS, the District has reviewed and determined the actual costs incurred in connecting a customer to its system and desires to amend the amount of its tap fee as previously set forth in Ordinance No. 97-1.

NOW, THEREFORE, be it ordained by the Board of Trustees of Jennings Northwest Regional Utilities, as follows:

**Section 1. Definitions.** For the purpose of this Ordinance, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"Owners of Real Estate" means an individual, firm, company, association, corporation, governmental unit, or charitable or other nonprofit organization.

**Section 2. Tap Fees:**

- A. After adoption of the Ordinance, the District shall not allow final and permanent connection to its sewage and water facilities until payment has been made to the District for the appropriate tap fees.
- B. The tap fees reflect the costs associated with connecting or "tapping" each customer to the District's sewer and water system. Where a single customer shall make multiple connections, an appropriate multiple of the single tap fee shall be charged.
- C. Tap fees shall be strictly non-refundable.

- D. The single tap fee for connection to the District's water facilities are as follows:

<u>Size of Meter Installed</u>	<u>Fee</u>
5/8" x 3/4"	\$400
3/4" x 3/4"	Cost of
1 inch	Time and
2 inch	Materials

- E. The single tap fee for connection to the District's sewage facilities shall be \$825.00 per connection.
